Terms and Conditions for Participating of the

2021 X-Ultra-4 GTX contest

1. General Terms

By participating in the 2021 X-Ultra-4 GTX contest ("Promotion"), you accept these Terms. Please read these Terms carefully before participating. If you do not agree to the Terms, you may not participate in the Promotion.
